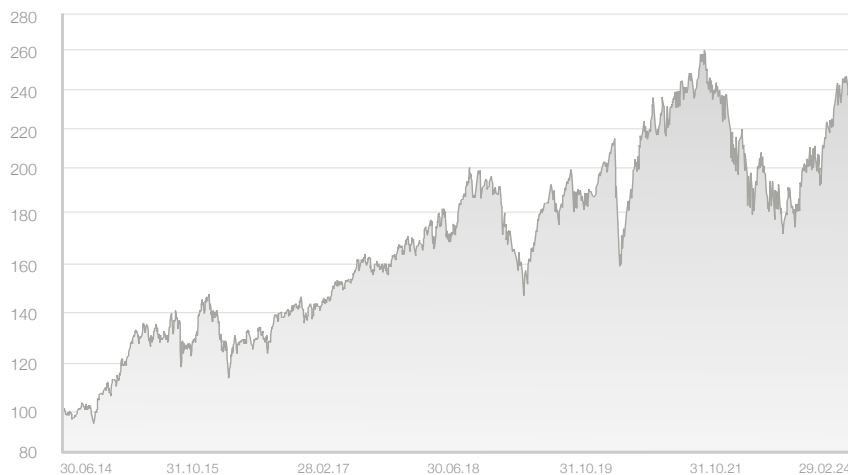


## ECOMMERCE FUND FACT SHEET

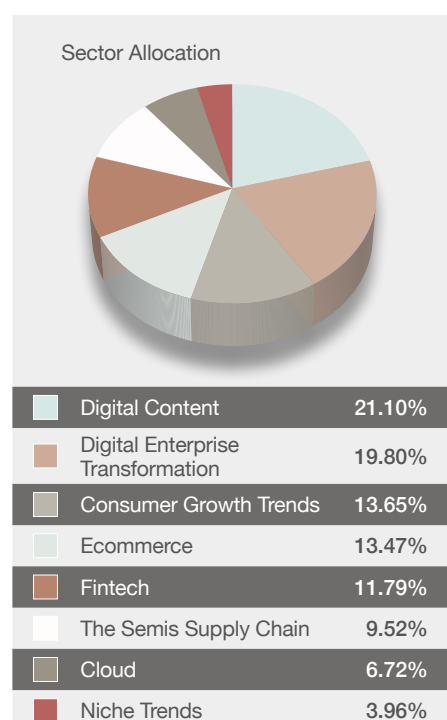
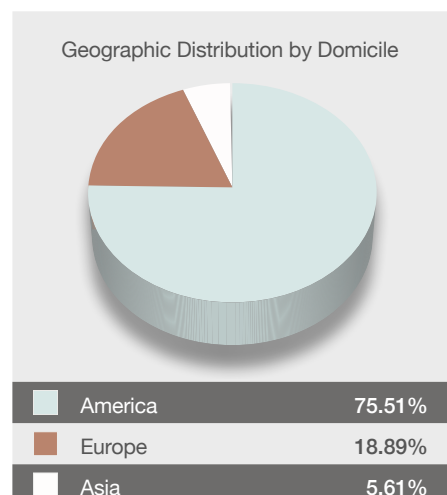
