1. Redemption

Where a completed Redemption Notice is submitted by facsimile or email the original must be immediately forwarded to the Administrator by post.

I/We being the registered holder/s of Shares in Opportunities Plus Fund (the "Fund") hereby apply to have the number of Shares/Currency amount indicated above redeemed subject to the terms of the current Offering Memorandum and the Articles of Incorporation of the Fund.

Subject to the terms of the Offering Memorandum, the minimum shareholding in the Fund is USD10,000. I/We agree that, if the redemption requested above results in my/our shareholding falling below the required minimum, the Administrator may redeem my/our total holding and forward the proceeds in accordance with the instructions given above.

I/We hereby appoint any Director or the Administrator as my/our agent to execute on my/our behalf all and any such transfers of such Shares as the Administrator may require or consider appropriate to give effect to this request. Please note that the Administrator may require additional customer due diligence documentation in order to process your redemption request as described in the Offering Memorandum. If satisfactory evidence is not produced upon such a request, redemption proceeds may be held in a separate bank account until all requested documentation has been received and is in order.

2. Redemption Payment Instructions

1. Requests for redemption will not be accepted unless this section is completed in terms acceptable to the Fund.
2. I/We hereby request and authorize the Administrator to make payment of the redemption proceeds in accordance with the above instructions.
3. I/We acknowledge that in effecting the payment in accordance with this request, the Administrator and the Fund shall be discharged from all other obligations or liability in respect of the said Shares and their redemption.

Redemption proceeds will only be paid to a bank account in the name of the investor(s).
